COUNCIL TRAINING AND ORIENTATION

December 7, 2022 from 9:00 a.m. to 4:15 p.m.

On December 7, 2022, the College held its virtual Training and Orientation session for all Council members and non-Council committee members.

The College invited Dr. Ruth Gallop, Professor Emeritus at the University of Toronto, to speak about sexual abuse prevention and the nature of the practitioner—patient relationship. Council learned more about the types of behaviours and boundary violations that may constitute abuse and the responsibility of the College and its members to protect the public from harm.

Ms. Rebecca Durcan spoke with Council and non-Council Committee members on the importance of regulatory governance including roles and responsibilities, structure, and goals. An overview of the College Performance Measurement Framework, recommendations from governance reports, and changes occurring in governance modernization in both Ontario and other provinces were provided. Ms. Durcan also provided an introduction to reasons and decisions writing, including the steps on how to draft reasons, and helpful tips to improve reasons writing.

The College also invited Dr. Nafeesa Jalal who presented on diversity, equity, inclusion, and how it applies to decision makers. Attendees were also educated on cultural competence, power and privilege, bias and unconscious bias.

The Council was advised that a by-election of District 3 and 5 would be held in 2023. Council directed the Registrar and CEO to set the by-election date of District 3 and 5 to be held on May 11, 2023.

Dr. Title Working Group

An update on the progress of the Doctor Title Project was provided. No proposals were received for the RFP for a consultant to assist with Phase 2 of the Doctor Title Project. The deadline was extended and the RFP was reposted on various platforms, and also sent to several consultants.

Risk Management Report

It was reported that changes have been made to the College's risk management plan, namely being the risk matrix, possibility/impact level of some risks, and new risks have been added.
