# MEETING OF COUNCIL Highlights

March 1, 2016 from 9:00 a.m. to 1:00 p.m. 705-55 Commerce Valley Drive West, Thornhill, ON L3T 7V9

There have been some changes in leadership at the College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario (CTCMPAO).

Effective February 26, 2016, Allan Mak, the former Director, Administration and Professional Practices, became the College's Interim Registrar and Chief Executive Officer. Mr. Mak has worked at the College since April 1, 2012 including as Acting CEO from June to December 2013. He has a strong vision and excellent institutional knowledge, and we are confident in his ability to effectively lead the College and regulate the profession in the public interest.

Mr. Mak assumes the role from Cristina De Caprio, who had been the College's Registrar and CEO since December 2013.

During her tenure, Ms. De Caprio delivered the CTCMPAO Transparency report to the Ministry of Health and Long Term Care which outlined current CTCMPAO practices that reflect transparency and a commitment to further increase transparency. Ms. De Caprio also oversaw the creation of a Standard of Practice on the prohibition of a sexual relationship with a Patient and was a leading force in several successful College legal challenges.

The College would like to thank Ms. De Caprio for her contribution to the profession.

### INQUIRIES, COMPLAINTS AND REPORTS COMMITTEE REPORT

The 2015-2016 Inquiries, Complaints and Reports Committee (ICRC) Chair, Ms. Claudia Newman, referred Council and gave an overview of the number of files ICRC has dealt with and forwarded to discipline.

To date, the Committee has referred seven matters to the Discipline Committee; there have been seven written caution letters, one file requiring a member to complete a Specialized Continuing Education and Remedial Program (SCERP) and five decisions to take no action. ### PATIENT RELATIONS COMMITTEE REPORT

The 2015-2016 Patient Relations Committee Chair, Phil Schalm, referred Council to the Patient Relations Committee's report.

Mr. Schalm brought forward for approval the four forms needed to execute provisional funding of therapy for survivors of sexual abuse.

- Form C: Request for Reimbursement of Past Therapy Costs
- Form D: Form signed by Therapist upon Submission of Invoice for funding of therapy and counselling for sexual abuse victims.

Council approved the forms as revised.

### DISCIPLINE COMMITTEE REPORT

Four pre-hearing conferences have been scheduled for late March and early April regarding four matters that have been referred to Discipline. The College is continuing to schedule pre-hearing conferences for the remaining matters.

The 2015-2016 Fitness to Practise Committee Chair, Phil Schalm, referred Council to the Fitness to Practise Committee's report.

The Committee has not met, as there has yet to be a case referred to the Fitness to Practise Committee.

# STANDARD OF PRACTICE (6): PROHIBITION OF A SEXUAL RELATIONSHIP WITH A PATIENT

Council reviewed the feedback in response to the Consultation and it was noted that there had been positive feedback and that the Standard has been well developed.

The Standard of Practice outlines the benchmark of interactions between Patients and Practitioners, and describe how situations should be handled so misconduct can be avoided.

The Standard of Practice is another step solidifying The College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario's commitment to a

zero tolerance attitude towards sexual abuse.

Council approved the sixth Standard of Practice on prohibition of a sexual relationship with a patient.

### BY-LAW AMENDMENT TO SECTION 200 OF THE CTCMPAO BY-LAWS

The College, for this one year only, was proposing to forgo the increase in membership fee, which would otherwise be applicable in 2016 under the existing By-Laws.

The membership fee rate increase under the existing By-Laws will resume for the June 1, 2017 renewal period.

Council Reviewed the feedback provided during the consultation and approved the following amendment to the College By-Laws:

200. Effective April 1st, 2017, and each April 1st thereafter, each fee described in these By-laws shall be increased by the percentage increase in the annual Consumer Price Index for goods and services in Ontario as published by Statistics Canada or any successor organization plus two percent (2%) and rounded up to the nearest dollar.
