What is CTCMPAO?

The College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario regulates the practice of Traditional Chinese Medicine (TCM) in Ontario. We are mandated to regulate the profession of TCM, in the public interest, through the Regulated Health Professions Act, 1991, and the TCM Act, 2006. In order to achieve this mandate, the College must fulfill the primary responsibilities outlined below.



The College's Responsibilities



We inform practitioners of their responsibilities, and inform the public on the level of care they can expect to receive from our practitioners.

We ensure practitioners engage in continuous quality improvement throughout their careers in the interest of protecting the public.

We set the requirements for becoming a Traditional Chinese Medicine Practitioner and/or Acupuncturist in Ontario.

We investigate and respond to concerns regarding practitioners' conduct, competence and/or the quality of care provided.

THE COLLEGE'S COMMITTEES

The governing body of the College is its Council, which is its Board of Directors and is responsible for policy setting and oversight of the affairs of the College. There are a number of statutory and non-statutory committees that determine various College matters. Each statutory committee is composed of both public and professional members. The public members are Ontario Government appointed members of the Council, while professional members may be elected members of the Council or non-Council professional members.

Executive Committee

The Executive Committee reports to Council, and functions to assist Council in fulfilling its duties. Among the ways it does this is by taking on tasks delegated to it by Council, suggesting priorities for agenda items, and acting in emergencies in between Council meetings. Decisions made on behalf of Council are then ratified by Council at the next meeting of Council.

Registration Committee

The Registration Committee is mandated to ensure the protection of the public interest by providing strategic direction to the College and to the Registrar with regard to the registration processes of the College.

Quality Assurance Committee

The Quality Assurance Committee is mandated to protect the public interest by creating a quality assurance program that monitors and encourages members to practise competently and ethically.

Inquiries, Complaints and Reports Committee

The Inquiries, Complaints and Reports Committee is mandated to protect the public interest by establishing policies and procedures to direct the actions of the College or its staff with respect to complaints received about members of the College. The committee also appoints panels to review complaints and consider reports against members of the College.

Discipline Committee

The Discipline Committee is mandated to protect the public interest by establishing and maintaining a framework for dealing with matters referred to it for discipline by the Inquiries, Complaints and Reports Committee.

Fitness to Practise Committee

The Fitness to Practise Committee is mandated to protect the public interest by establishing and maintaining a framework for dealing with matters referred to it for incapacity by the Inquiries, Complaints and Reports Committee.

Patient Relations Committee

The Patient Relations Committee is mandated to ensure the protection of the public interest by administering, monitoring and amending the Patient Relations Program. The Patient Relations Program includes measures for preventing or dealing with sexual abuse of patients by members of the College. The Committee also administers the funding for therapy and counselling for patients who were subjected to sexual abuse by members of the College.

Doctor Title Working Group

The mandate of the Doctor Title Working Group is to prepare recommendations to the Council and Executive Committee for the development of the "Dr." Title Class regulation. The working group shall conduct research, synthesize information, make recommendations and undertake project activities at the request of the Council for development of the "Dr." Title Class regulation.





I believe as we commemorate the 10 Anniversary of the College, we have risen to the occasion as a "College striving for excellence in governance and in regulating the practice of the TCM profession". Congratulations to all in making this a reality! The last year (2022-2023) has been revitalizing, filled with passion and revival of the TCM community, inspired and committed to regulation and a sense of renewal!

It has been an extraordinary, productive year! We committed to ongoing efforts to align with government priorities in bringing forward an Emergency Class of Registration and submitted a proposed Provisional Class that reflects the uniqueness of the profession we regulate to ensures safe, quality care to Ontarians.

I am proud of this College's achievements and thank our Registrar, staff and Council for their resilience and commitment to move forward in implementing the new Strategic Plan. This year, unprecedented initiatives were undertaken in implementing the Performance Measurement Framework, Governance Reforms, Phase 2 of the Doctor Title Project and delivering on the Government directives to remove barriers to registration and offer the Pan Canadian exam in Chinese. These directives did not significantly impact our registration requirements as our College has always exempted the language requirement, providing flexibility and opportunity to international trained applicants seeking to enter the profession in Ontario. In addition, the Quality Assurance Enhancement Program, Accreditation/Approval Project, and the development of Acupuncture Standards are progressing as planned.

Our Strategic planned activities for the next 5 years will increase public confidence in accessing safe, qualified TCM professionals of their preference and increase opportunities for patients to consult TCM practitioners working in collaboration with health care professionals.

It was a privilege to have had the opportunity to mark June 14, 2023, as our official Celebration of the 10th Anniversary of the proclamation of the Traditional Chinese Medicine Act, 2006 on April 1, 2013 and the establishment of "The College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario". The Minister of Health, the Honourable Sylvia Jones extended her Congratulations by video conferencing and MPP Daisy Wai attended acknowledging our achievements!

The 10th Anniversary was a Celebration of the past and no doubt the future success of Regulation of the TCM profession in fulfilling our mandate to protect the public embracing diversity, equity, and inclusion!

Congratulations again! I am confident the College will continue to build upon the many achievements this year with the same enthusiasm, dedication, and commitment in the coming year in the interest of the public!

MESSAGE FROM: OUR REGISTRAR & CEO

The 2022-2023 year for the College was one of renewal, as we moved forward from challenges faced in the previous years. I am proud of how quickly the College was able to move forward on long-needed projects that will benefit public safety for TCM patients, and provide better resources to public, members and applicants to the College. My sincere gratitude goes out to the College Council, our dedicated staff, and all stakeholders who have supported us throughout this journey.

Upon the College Council becoming properly constituted in March 2022, the immediate priority for the College was to develop a new strategic plan. With the assistance of third-party consultants, Council and staff worked throughout the year to identify strategic priorities that would guide the College through a time of regulatory modernization. The College sought to develop a strategic plan that would position us to anticipate and adapt to changes while maintaining our commitment to effectively regulating the profession of traditional Chinese medicine in the public interest. After extensive deliberation and consideration, the new, five-year strategic plan was approved by Council in March 2023. This new plan is effective April 1, 2023, and will steer the College's path until 2028.

Another significant achievement this past year was the successful delivery of the Pan-Canadian Examinations in Chinese. In March 2022, The Ministry of Health requested that the College begin offering the Chinese version of the entry-to practice examination to expand access to those looking to enter the profession. In collaboration with our national regulatory partners, the College was able to fully meet this expectation.


In addition to these successes, the College has made substantial progress on strategic projects that had previously experienced delays. For example, the College Doctor Title Project, the Quality Assurance Program Enhancement Project, and the School Program Approval Project have all moved forward significantly in the past year. These projects aim to improve the way the College regulates the profession in the public interest, and I look forward to continuing work on them in the new year.

The College continues to use targeted, measurable communication channels to reach the stakeholders and provide updates and gather information such as, public consultations, webinars, and frequently asked questions. Activity Highlights

- Completion of the Self, Peer and Practice Assessment Tools of Phase II of the Quality Assurance (QA) Program Enhancement Project.
- This process included stakeholder consultation with registrants throughout various points in the process. We very much thank the participants for their feedback and/or participation.
- The Council approved the Telepractice Guideline to help registrants understand their accountabilities when providing care using telecommunication technologies.

Annual Requirements of the QA Program

Every registrant of the College must annually complete a self-assessment and 15 hours of professional development activities. Each year the QA Committee requires a percentage of registrants to submit their Self-Assessment and Professional Development tools for review.

For the year of 2022, approximately 2% or 56 registrants were selected. The results are as follows:

Activity Highlights

> In 2022-2023, the Patient **Relations Committee** held 3 meetings

- The Committee approved one application for funding for therapy and counselling. A patient is eligible for funding if it is alleged in a complaint or report that they were sexually abused by a member. Two previously approved applications remain active and continue to receive funding.
- The College engages the public through it's website, social media accounts, and through participation with the Citizens Advisory Group. The College continues to explore additional ways to increase public engagement.

Established standardized presentation content for members/registrants and the patient/public for future use.





Doctor Title Working Group

After delays caused by the unconstituted status of Council in previous years, the College was able to appoint a new Doctor Title Working Group to begin work on the College's Doctor Title Project. The Working Group began Phase 2 of this important project by approving a request for Proposal for a consultant to help draft Doctor Title competencies and create an assessment process, among other deliverables. The request for proposal was released in September 2022, and by January 2023, a number of proposals had been received.

In March 2023, the Working group met to discuss and review the received proposals. After review, recommendations were made to Council for a final decision.

At the March 22, 2023 Council meeting, Council reviewed the proposals and recommendations from the Working Group, and selected a consultant to begin work on this project. The consultant is set to work throughout the 2023-2024 fiscal year to complete Phase 2 of the Doctor Title Project.

CARB-TCMPA TCM Accreditation Program

One of the key activities identified in the College's Strategic Plan is to find opportunities for inter-college and inter-profession collaboration; and identify program approval criteria and initiate a process to ensure education of competent practitioners. The CARB-TCMPA TCM Program Accreditation Project is in alignment with the College's Strategic Plan because it is a collaborative initiative with other provincial regulators and the project will help the College form a program approval process that will increase public confidence and further public safety.

Throughout the 2022-2023 year The College worked with CARB-TCMPA to develop standards for TCM education. The College is excited to move toward implementation of program approval in Ontario in the new year and be able to provide the College and the public with more confidence in the TCM education system in Ontario.

PUBLIC CONFIDENCE

Regulatory Investigations and Discipline

Discipline Committee

The Discipline Committee is an independent committee within the College that conducts formal hearings to review allegations of professional misconduct or incompetence on the part of a Traditional Chinese Medicine Practitioner and/or Acupuncturist.

The Committee determines appropriate penalties where the allegations are proven, to discipline the Traditional Chinese Medicine Practitioner and/or Acupuncturist in an effort to protect the public from future risk of harm. Matters are referred to the Discipline Committee by the ICRC.

In 2022, the ICRC referred four (4) matters before the Discipline Committee. The College released five (5) discipline decisions in the year.

As part of the College's duties under the Regulated Health Professions Act, 1991 (the "RHPA") matters that end up being prosecuted before the Discipline Committee are often complex, time consuming and expensive. Cost awards issued from discipline are often intended to only indemnify the successful party for resources expended from enforcing the legislation.

\$77,818.45 in cost recovery awards were issued to the College through discipline proceedings.[1]

Inquiries, Complaints and Reports Committee

The College's mandate is to regulate the profession in the public interest. Anyone with concerns about a Registered Traditional Chinese Medicine Practitioner and/or Registered Acupuncturist can submit information and/or file a formal complaint to the College. In this past year, the ICRC transitioned to conduct all panel meetings, committee meetings in a virtual environment. The ICRC Implemented the use of new technology in facilitating meetings to ensure that the College's regulatory work continued effectively and efficiently.

In 2022, the College received 17 complaints which is a slight reduction in formal complaints from 2021. (10.53% decrease)

Compliance

At the conclusion of some ICRC matters, ICRC from time to time may order a member to complete a Specified Continuing Education or Remediation Program. (SCERP)

The College began an internal process to modernize and standardize the College's Compliance Monitoring activities.

Compliance activities previously conducted in person, were transitioned (where possible) to a virtual platform in light of the pandemic.

GOOD GOVERNANCE

Working with Health System Partners

In 2022-2023 the College continued its participation in the Anti-BIPOC Racism Working Group with our regulatory partners in Health Profession Regulators of Ontario (HPRO). This working group aims to improve college's best practices. Through this project, health regulators have been able to develop tools custom made for the health regulatory field to help Colleges assess their EDI practices, and identify areas for improvement. The College is looking forward to making use of these tools going forward to help create a more equitable health care system for Ontarians. The College has also continued its productive relationship with the Office of The Fairness Commissioner (OFC). In particular, the College received valuable feedback from the OFC in drafting amendments to the College's Registration Regulation.

In addition, the College continued its previous collaboration projects, such as the Citizen Advisory Group.


CPMF Project

On March 31, 2023, the College submitted its 2022 College Performance Measurement Framework (CPMF) report to the Ministry of Health. The CPMF seeks to answer the question "how well are Colleges executing their mandate which is to act in the public interest?". The framework includes 7 domains, and within those, asks if the College is meeting a number of requirements. The first, and largest of these domains is Governance.

In this report, the College has made a commitment to develop and implement a competency-based assessment process for determining eligibility for Council elections. The College has committed to make progress on this in the 2023-2024 fiscal year.

Council/Committee Training

The College provided extensive Council and Committee training necessary for Council and Committee members to fulfill their duties and responsibilities in the interest of the public. It is important that Council and Committee members possess the necessary knowledge to effectively participate in decision making at Council and Committee meetings. Various guest speakers were invited to provide information on topics such as the prevention of sexual abuse, governance, decision writing, EDI, and an intro to TCM.




GOOD GOVERNANCE

Strategic Plan: 2023 - 2028

Upon Council regaining proper constitution of members in 2022, the creation of a new strategic plan became an immediate priority. The previous strategic plan had expired in 2021, and the College was without proper direction for its strategic projects. Council approved a consultant to assist in the development of a strategic plan, who worked with staff and Council, and sought input from stakeholders like the Ministry of Health, TCM patients, and members of the College.

The new strategic plan was approved by Council at the March 22, 2023 Council meeting, and was in effect for the new fiscal year starting April 1, 2023. After this date, the College will be guided by the new strategic priorities of effective right touch regulation, continuous quality improvement, informed and interactive stakeholders, and modernized governance.



With the priority of modernized governance, in addition to the Council competencies required by the CPMF, the College will look to find improvements in our governance practices to ensure the College is meeting expectations of the public.



PRACTITIONER COMPETENCE

College Communications to Improve Practitioner Competence

The College has continued to identify educational opportunities to strengthen practitioner competence and help ensure patients receive a high quality of care. In the 2022-2023 fiscal year, the College continued to publish its series of Educational Tips emails to members.

These emails help educate members on professional responsibilities, safe practice, and any changes in the regulatory environment that members need to be aware of. It is also a way for the College to address frequently asked practice related questions from members, or emerging trends in the regulation of TCM.

The emails are available in both English and Chinese to make this necessary information more accessible to members who may have English as a second language.

The College also continues to publish its quarterly "Qi News" enewsletters to keep members and stakeholders informed on the College's activities, department updates and announcements.

Webinars

To provide members with a more in-depth educational experience on College requirements, the College continued to hold webinars on important topics.

In 2022-2023, the College held webinars on:

- Telepractice March 10, 2023

PRACTITIONER COMPETENCE

Regulatory Amendments

In the 2022-2023 fiscal year, the Registration Committee began work on regulatory amendments to create two new classes of registration – the Emergency Class and Provisional Class. The Emergency Class has been mandated by the Provincial Government for all health Colleges, while the Provisional Class has been initiated by the College to provide expanded registration options.

With a focus on the public interest, the Committee considered the criteria for an Emergency to be invoked, the exemptible and non-exemptible requirements for applicants to each class, and appropriate conditions under which registrants in the new classes can practise. The Committee's recommendations were then brought to the College's Council for further consideration.

Quality Assurance Program Enhancement Project

In 2022-2023, the Quality Assurance Committee began work on Phase 2 of the QA Program Enhancement Project. The College sought the help of a consultant to develop new self-assessment and peer and practice assessment tools to help get more meaningful engagement in these assessments. This work will continue through 2023-2024, with the aim to provide members with helpful resources.

Pan-Canadian Examination in Chinese

Pursuant to a request from the Ministry of Health, the College introduced a Chinese-language option for the entry-to-practice examinations. In October 2022, the Acupuncturists exam was offered for the first time in both Traditional and Simplified Chinese, in addition to English, with plans to offer a Chinese version of the Practitioners the following year. Having the option to write the exams in Chinese helps to reduce barriers to the profession, making it more accessible to a wider segment of the community.

To promote the availability of the new offerings, the College advertised the expanded language options widely through a variety of Chinese-language media outlets, including social media channels.



STAKEHOLDER COMMUNICATIONS

Stakeholder Consultations

Throughout 2022-2023, the College made it a priority to engage its primary stakeholders and system partners in consultation efforts. This can be demonstrated in the projects mentioned in this report, such as the College's strategic plan, the QA Program Enhancement Project, and Regulatory Amendments, which all included a fulsome effort to collect feedback from stakeholders. These consultation activities have proved invaluable to the College and have given important perspectives and information. The College will continue to engage its stakeholders for consultation on important projects going forward.

Meetings with TCM Associations

The College regularly reaches out to its stakeholders to hold meetings and maintain an open communication channel. In the wake of Bill 88 in February 2022, the College Council wished to take particular care to meet with representatives of the profession to hear and address their concerns. The College met with Association representatives on June 27, 2022 for fulsome discussion on important matters facing the Regulation of TCM.

Meetings with Ontario Educators and Students

The College recognizes the importance of communications with educators and students to develop meaningful and responsive relationships. These dialogues focused on ensuring their understanding of the College's activities and processes and encouraging feedback and questions.

- On August 23, 2022 the College held its annual meeting with Ontario TCM schools. Staff provided an update on College activities related to registration, accreditation project; Online Learning Policies and Chinese language entry to practice examination. Dan Garcia, Executive Director, the Canadian Alliance of Regulatory Bodies of Traditional Chinese Medicine Practitioners and Acupuncturists (CARB-TCMPA), provided an update on the Pan-Canadian Examinations.
- The meeting included an FAQ session to provide an opportunity for schools to ask questions. The meeting was attended by 19 representatives from 13 schools.
- Six Ontario schools invited College staff to present to their graduating students in June 2022 December 2022 and January 2023. There were 106 attendees who joined the virtual and inperson presentations. The sessions included an overview of the CTCMPAO registration, examination process and Language Fluency Policy.

What is a Public Member?

Public members are appointed to Council by the Ontario Government. Council must have a minimum of five and no more than eight publicly appointed members. Public members, as with all Council members, uphold the College's mandate to serve and protect the public.

What is a Professional Member?

Professional members are elected to Council by members in the five districts, up to a maximum of nine professional members. Professional members bring a unique perspective through their knowledge of the profession and serve as a Council member to protect the public.




